A RESOLUTION AUTHORIZING THE PURCHASE OF HOSPITALIZATION INSURANCE FOR THE LITTER GRANT ADMINISTRATOR.

WHEREAS, Council has previously authorized the Litter Grant Administrator to have the same amount of insurance as is provided to the Police Chief of the Village of Buckeye Lake, and

WHEREAS, Council is desirous of purchasing hospitalization insurance for the Litter Grant Administrator.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF BUCKEYE LAKE, COUNTY OF LICKING AND STATE OF OHIO, that:

Section 1: The Mayor and Clerk are authorized to contract, on behalf of the Village of Buckeye of Lake, Ohio, with the Farnsworth Insurance Agency for an insurance policy for the Litter Grant Administrator in an amount not to exceed \$1,446.47 for said policy's premium for a six-month period.

Section 2: This Resolution shall go into full force and effect from and after the earliest period allowed by law.
