A RESOLUTION AUTHORIZING AND DIRECTING THE MAYOR AND CLERK TO ENTER INTO CONTRACT FOR THE PURCHASE OF STORM SEWER DRAINAGE PIPE WITH UNIVERSAL CONCRETE OF COLUMBUS, OHIO.

WHEREAS, Council desires to implement a storm sewer drainage project to eliminate surface water in the area of State Route #79 in the Village of Buckeye Lake, Ohio; and,

WHEREAS, Universal Concrete of Columbus, Ohio, has informally bid \$4,995.20 for 1,120 feet of 21" concrete pipe; and,

WHEREAS, This amount appears to be the best informal bid submitted for such project.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF BUCKEYE LAKE, COUNTY OF LICKING AND STATE OF OHIO, THAT:

- Section 1: The Mayor and Clerk are hereby authorized to enter into a contract with Universal Concrete Company of Columbus, Ohio, for the purchase of 1,120 feet of 21 concrete pipe in an amount not to exceed \$4,995.20.
- Section 2: An emergency is hereby declared to exist in that the current condition of State Route #79 following a heavy rainfall is dangerous to individuals traveling on said highway and by implementing the drainage project at the earliest possible time, will enable the Village to better protect the life and property of travelers on said highway.

Section 3: This Resolution shall go into effect immediately.
