A RESOLUTION URGING THE STATE OF OHIO, DEPARTMENT OF NATURAL RESOURCES, TO CONTINUE TO PROCEED IN PLANS TO DEVELOP A PUBLIC PARK FACILITY ON THE NORTH BANK OF BUCKEYE LAKE.

WHEREAS, this Council wishes to go on record supporting the preliminary work done by the Ohio Department of Natural Resources in developing a public facility on the North Bank of Buckeye Lake within the Village of Buckeye Lake, Ohio; and

WHEREAS, Council urges the State to continue to pursue the development of this project; and

WHEREAS, implementation of a public facility on the North Bank of Buckeye Lake will be a great benefit to the residents of the Village as well as people from all over the State who utilize Buckeye Lake as a resource.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF BUCKEYE LAKE, COUNTY OF LICKING AND STATE OF OHIO, that:

Section 1: The Village government urges the State of Ohio to pursue the development of the North Bank of Buckeye Lake as a public park facility.

Section 2: The Village urges the State to continue to consider the proposed site of the facility as a viable location for the facility.

Section 3: The Village pledges its cooperation in assisting the State in this endeavor.

Section 4: The Village urges the present property owner and the State to come to agreement on the question of the value of the land so as to facilitate the development of the project.

Section 5: This Resolution shall go into full force and effect from and after the earliest period allowed by law.
