A RESOLUTION ESTABLISHING HIGHER SALARIES FOR THE POSITION OF CHIEF OF POLICE AND THE POSITION OF SERGEANT OF THE POLICE DEPARTMENT.

WHEREAS, Council desires to raise the salaries of the Chief of Police and Sergeant of the Police Department of Buckeye Lake, Ohio.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF BUCKEYE LAKE, COUNTY OF LICKING AND STATE OF OHIO, that:

Section 1: The per annum salary of the Chief of Police of the Village of Buckeye Lake is hereby raised to the amount of \$ 15,500. This raise represents a \$500.00 per annum increase in such salary.

Section 2: The per annum salary of the Sergeant of the Police Department of the Village of Buckeye Lake is hereby raised to the amount of \$ 12,500. This raise represents a \$500.00 per annum increase in such salary.

Section 3: This Resolution shall go into full force and effect from and after the earliest period allowed by law.
