A RESOLUTION AUTHORIZING THE HIRING OF JAMES SLOCUM AS STREET SUPERVISOR AND SETTING SAID SUPERVISOR'S HOURS AND WAGES.

WHEREAS, a vacancy exists in the position of Street Supervisor due to the resignation of the previous supervisor; and

WHEREAS, Council desires to appoint a new individual to said position.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF BUCKEYE LAKE, COUNTY OF LICKING AND STATE OF OHIO, that:

Section 1: James Slocum is hereby hired as Buckeye Lake Street Supervisor. He shall serve until such time as he resigns or is removed by Council.

Section 2: The Street Supervisor's hours of employment per week shall be limited to thirty-five (35) and he shall be compensated at a rate of \$4.75 per hour.

Section 3: This Resolution is made retroactive to the 31st day of March, 1986.

Section 4: This Resolution shall go into full force and affect from and after the earliest period allowed by law.
