A RESOLUTION AUTHORIZING THE EMPLOYMENT OF LEROY WALKER AS BUCKEYE LAKE LITTER SUPERVISOR.

WHEREAS, a need exists to hire a part-time worker to act as a litter supervisor; and

WHEREAS, Council has selected an individual it believes will perform these duties in an acceptable manner.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF BUCKEYE LAKE, COUNTY OF LICKING AND STATE OF OHIO, that:

SECTION 1: Leroy Walker is hereby hired as an employee of the Village of Buckeye Lake, Ohio, in the capacity of Litter Supervisor.

SECTION 2: Leroy Walker, as said Litter Supervisor, is authorized to work no more than thirty-five (35) hours per week.

SECTION 3: The Clerk-Treasurer is hereby authorized to compensate the Litter Supervisor at a rate of \$4.75 per hour. Said funds shall be withdrawn from the Litter Grant Fund and, if such funds are ever terminated or expire then, said position of Litter Supervisor shall be abolished.

SECTION 4: This Resolution shall go into full force and effect from and after the earliest period allowed by law.
