# LICKING COUNTY LITTER PREVENTION AND RECYCLING

Grant Agreement No.

This agreement is entered into by and between the Village of Buckeve Lake, Buckeye Lake, Ohio, hereinafter "Agency", and the Licking County Office of Litter Prevention and Recycling, hereinafter "Board", collectively referred to as "Parties".

Whereas, the "Board" has applied for and obtained a grant from The Ohio Department of Natural Resources, Office of Litter Prevention and Recycling, for the purposes of litter prevention and recycling within Licking County.

Whereas, the "Board" has agreed to sub-grant monies to the "Agency" for the purposes of litter prevention in what is commonly known as the "Buckeye Lake Region".

The "Parties" have entered into the following agreement:

#### THE AGENCY AGREES:

- Personnel matters surrounding the sub-grant, shall be resolved by mutual decision of Village Council and the County Litter Program Administrator. All sub-grant personnel will report directly to the County Administrator.
- 2) Understanding that the "Board" will do everything in its power to help correct the litter problem in Buckeye Lake, the "Agency" agrees to do the same regarding private property code violations. More specifically, the "Agency" will punish, to the full extent of the law, any and all code violators pertaining to litter and trash on private property.
- 3) The County's obligation to the "Agency" is fully contigent upon funding from the Ohio Department of Natural Resources, when funds are specifically earmarked for this sub-grant.
- 4) All rules and regulations set forth by the Department of Natural Resources are to be followed to the letter. Should any purposeful discrepancies evolve, the "Board" will have the right to terminate the sub-grant agreement.
- 5) To communicate on a regular basis any and all successes or problems that impact on either the positive or negative outcome of the project, for the purpose of mutual discussion between the "Agency" and the "Board".
- 6) To work within the following budget: (All expenses shall be incurred and paid by the "Agency" and subsequently reimbursed by the "Board").

- 7) To invoice the "Board" at the end of each month for all covered expenses. Any expenses incurred by the "Agency" that are not outlined in this budget, are the sole responsibility of the "Agency" and therefore are not reimbursable by the "Board".
- 8) That it is by unanimous Village Council decision, that the County administer this sub-grant. In return, the "Agency" agrees to abide by all conditions previously set forth in this agreement.

### THE BOARD AGREES:

- 1) To assist in the hiring of any necessary personnel.
- 2) To provide technical assistance to the "Agency" whenever necessary.
- 3) To set aside time for regularly scheduled meetings for the purpose of reviewing the progress of the project.
- 4) To convey any and all directives and information from O.D.N.R./O.L.P.R. to the "Agency" that may be considered pertinent to the project.
- 5) To reimburse to the "Agency" for all covered expenses, in a timely manner, approximately the 15th of each month, provided the "Agency" invoices the "Board" at the beginning of each month.

## THE PARTIES AGREE:

- That the terms of this agreement shall begin on 8/1/86 and end on 12/31/86, unless extended or modifed by mutual agreement of the "Parties".
- 2) That the "Board" and the "Agency" has adopted appropriate legislation to enable them to enter into this agreement.
- 3) That this agreement may be modified, amended or terminated by mutual agreement of the "Parties".
