A RESOLUTION REQUESTING THE COUNTY AUDITOR OF LICKING COUNTY, OHIO, TO ADVANCE FUNDS AGAINST THE TAX SETTLEMENT OF THE VILLAGE OF BUCKEYE LAKE, OHIO.

WHEREAS, Section 321.34 of the Ohio Revised Code authorizes local authorities to request by resolution that the County Auditor pay to treasurers of municipal corporations funds which may be in the County Treasury to the account of the Village of Buckeye Lake, Ohio.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF BUCKEYE LAKE, COUNTY OF LICKING AND STATE OF OHIO, that:

Section 1: The Village Council hereby authorizes the Village Clerk/Treasurer to request from the County Auditor any funds which are payable by law to the County Treasurer and are payable to the account of the Village of Buckeye Lake, Ohio.

Section 2: This Resolution shall go into full force and effect from and after the earliest period allowed by law.
