A RESOLUTION OF INTENT TO VACATE A FIFTEEN FOOT WIDE ALLEY IN THE JOHN MYERS COTTAGE LOT ADDITION; SEE VOLUME 3 AT PAGE 309, LICKING COUNTY PLAT RECORDS, SAID ALLEY BEING BOUNDED BY LOT 51 AND 53 IN THE AFORESAID ADDITION.

WHEREAS, Buckeye Lake Village Council, during its November 14, 1988, meeting, received a petition from the owners of real estate in the Village of Buckeye Lake praying for the vacation of an alley in the John Myers Cottage Lot Addition in the Village of Buckeye Lake, Ohio, said petition being submitted in accordance with Section 723.04 of the Ohio Revised Code.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF BUCKEYE LAKE, COUNTY OF LICKING AND STATE OF OHIO, that:

Section 1:

The Buckeye Lake Village Council hereby declares its intent to vacate the following described alley:

Being the first alley east of Park Street running north and south in the John Myers Cottage Lot Addition, see Volume 3, at page 309, Licking County Plat Records, said alley being 15 feet in width and lying between lots 51 and 53 in said Addition.

Section 2:

Pursuant to Section 723.07 of the Ohio Revised Code, the Clerk of the Village shall give notice of the intent of this Council to vacate the alley hereinbefore described.

Section 3:

This Resolution shall take effect and be in force from and after the earliest period allowed by law.
