SECTION 1.

COUNCIL SUPPORTS THE PROJECT CONTAINED IN THE APPLICATION FOR FUNDING THE DISBURSEMENT OF STATE ISSUE 2 MONIES AND, IF SUCH APPLICATION IS APPROVED, COUNCIL WILL IMMEDIATELY IMPLEMENT THE RESURFACING PROJECT.

SECTION 2.

COUNCIL IMPLORES THE COMMITTEE TO LOOK FAVORABLY UPON THE VILLAGES' APPLICATION SO THAT THE ROAD MAY BE RESURFACED AT THE EARLIEST POSSIBLE TIME.
