A RESOLUTION STATING THE VILLAGE COUNCIL'S SUPPORT OF THE HOUSING PRESERVATION PROGRAM.

WHEREAS, the Council of the Village of Buckeye Lake believes that the housing preservation program as administered by the Licking County Planning Commission is one that will meet the needs of many individuals residing in the Village of Buckeye Lake; and

WHEREAS, Council urges the Farmers Home Administration to look favorably upon the Licking County Planning Commission's grant application.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF BUCKEYE LAKE, COUNTY OF LICKING AND STATE OF OHIO, THAT:

Section 1: The Village of Buckeye Lake, by passage of this Resolution, states its support for the housing preservation grant program application that the Licking County Planning Commission intends to submit to the Farmers Home Administration.

Section 2: The Village Council also urges the Farmers Home Administration to look favorably upon the Licking County Planning Commission's grant application inasmuch as the grant application, if approved, will undoubtedly benefit many low and very low income homeowners residing in the Village of Buckeye Lake, Ohio.
