A RESOLUTION AUTHORIZING THE MAYOR TO PURCHASE MOBILE RADIOS FROM JEFFERSON TOWNSHIP FIRE DEPARTMENT ON BEHALF OF THE VILLAGE OF BUCKEYE LAKE, OHIO, AND TO DECLARE AN EMERGENCY

WHEREAS, the Jefferson Township Fire Department has offered the Village of Buckeye Lake three (3) mobile radios at the cost of \$1.00 each; and

WHEREAS, the Buckeye Lake Village Fire Department desires to obtain said mobile radios; and

WHEREAS, the Village of Buckeye Lake is appreciative of the consideration extended to the Buckeye Lake Village Fire Department by the Jefferson Township Fire Department,

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF BUCKEYE LAKE, OHIO, TWO-THIRDS OF THE MEMBERS ELECTED THERETO CONCURRING THAT:

SECTION ONE:

The Mayor and Clerk are hereby authorized to purchase said mobile radios from the Jefferson Township Fire Department at the rate of \$1.00 each.

SECTION TWO:


This Resolution is declared to be an emergency measure necessary for the general health, safety and welfare of the citizens of the Village of Buckeye Lake and shall become effective upon its passage of two-thirds (2/3) of the members elected by the Council concurring; and if the vote of the Council is not sufficient to pass this as an emergency measure, shall become effective from and after the earliest period allowed by law.
