

**VILLAGE OF BUCKEYE LAKE, OHIO  
RESOLUTION NUMBER 2021-11**

**A RESOLUTION AUTHORIZING AND DIRECTING THE FIRE CHIEF TO  
ACCEPT THE ASSISTANCE TO FIREFIGHTERS GRANT (AFG) UPON  
AWARD AND THE DECLARATION OF AN EMERGENCY.**

**WHEREAS**, the Fire Department for the Village of Buckeye Lake is vital in maintaining a safe community for all who live, work, and visit; and

**WHEREAS**, the Fire Department is in great need of replacing its self-contained breathing apparatus, fire hose, nozzles, and other related fire equipment; and

**WHEREAS**, the Fire Chief has been notified that the Village of Buckeye Lake's AFG application has entered the pre-award phase of the grant process.

**THEREFORE, FOLLOWING AN AFFIRMATIVE VOTE OF AT LEAST TWO THIRDS  
(2/3) OF THE COUNCIL TO DISPENSE WITH THE REQUIREMENT OF THE  
BUCKEYE LAKE VILLAGE CHARTER SECTION 4.04 TO READ A RESOLUTION ON  
THREE SEPARATE DAYS WITH AT LEAST ONE WEEK BETWEEN READINGS,**

**NOW THEREFORE, BE IT RESOLVED BY THE VILLAGE OF BUCKEYE LAKE,  
COUNTY OF LICKING, STATE OF OHIO, THAT:**

SECTION I: Should the Village of Buckeye Lake be chosen for award of the 2020 Assistance to Firefighters Grant, the Fire Chief is hereby authorized and directed to accept the grant award on its behalf.

SECTION II: The Fire Chief is further authorized and directed to serve as the grant manager, and is thereby responsible for satisfying all reporting requirements of the program.

SECTION III: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decisions making bodies of the Village of Buckeye Lake which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

SECTION IV: That in order to protect the health, safety and welfare of the citizens of the Village of Buckeye Lake, this Ordinance is declared to be an emergency measure and it shall become effective on its passage and signature of the Mayor.
